



Race and Ethnicity in Juvenile Rehabilitation Administration (JRA)






WA State JRA Demographics ⁵





- 2. Kids are happy with what we bring, but that doesn't mean that we can't improve (fit for audience, quality of presentation or presenter)


- Check your professional ego.

- 4. Work to achieve project goals, but know that excitement for service can lead to scope creep
- 5. It's all about the individual connection with teens
- 6. Site buy-in and extensive follow-through
