## **WLA Membership Rates Proposal**

## Background

WLA's Member Services Committee proposed a \$20 introductory membership rate for new WLA members, with the goal of reducing financial barriers and increasing participation in WLA. The Finance Committee was in support of the Member Services Committee's proposal and wanted to take the opportunity to evaluate the entire dues structure, seeing an opportunity to create a more equitable framework for WLA's membership. WLA has not assessed or changed rates for individual members since 2012.

## **Proposal**

The WLA Finance Committee proposes the following restructuring of our individual membership dues, to take effect on January 1, 2025:

## **Benefits**


- The new rates streamlines our membership dues structure, moving from 14 rate tiers to 5.
- 79.35% of our salary rate members would have their annual dues decrease or stay the same, with a focus on reducing prices for our membership earning a salary of \$60k and below.
- The proposed rates, especially for our lower income membership (\$60k and below), are much more equitable when compared to other state library associations. Examples:
  - o California
  - o Colorado
  - o Oregon
  - o <u>Texas</u>

Takeaway: The proposed rates, if all current membership continues, will not result in a financial loss for WLA, and represents a very minor total increase from our current dues structure (\$990).

# Challenges

• The proposed rates increase between \$15-30 per year over our current rates for members making \$80k and above. While the Finance Committee believes that having more accessible rates for our lower income membership is the priority, there is a risk that some of our membership may be against this change. We propose an assessment of the impact of the rate changes on the membership tiers within 2-3 years of implemented change to calibrate membership rates.
