- Dashboard Report
 - Membership totals- up a little from October 2023
 - Looking forward to the numbers increasing because of the membership proposal being passed and the 2025 conference
- Election Results & New Leadership

 - Excited to work with the new board members and division/section leadership for 2025 and beyond!
 - New committee interest form closing this Friday -- spread the word!
- Board Retreat
 - October 27 at the Burien Public Library; 2024 and 2025 board members came together for half a day
 - Brainstormed ways to increase funding, membership
- Pawsident Fundraiser
 - Nominations are open!

State Library Report -- Sara Jones/Crystal Lentz Rowe

- Welcome back, Sara!
- Will need support during this upcoming legislative session
- Concerned about the presidential appointee; no problem under the prior Trump admin

Legislative Report-- Carolyn Logue

- Will be working with Reykdal again on the school side
- Will need to keep an eye on the senate seats for the D/R split

- House- Dem. has picked up a couple seats, close to the ²/₃ super majority
- We need to get a sense of where Ferguson stands on library issues
- WA budget could be in a bit of trouble, mostly because of all the spending that went on without thinking of the long-term effects
- Capital gains, long-term care, climate act- not going away
- Public library
 - Should be easier to get the money for the digital book purchasing study
 - Will need to make some strong arguments and possibly use some of the climate dollars in order to make this study happen
- School
 - Met with WEA, what's going to happen?
 - More money in special education and materials/supplies cost
 - Sen. Wellman- Staffing allocations for TL
 - Position at OSPI, some grant ideas
- Should have no problem about discussions regarding library staff (protecting schedules, etc.)
 Need some good examples with WA state examples
- Focus on why having a school librarian in place is more efficient
- Wireless device tax, broadband, digital equity
 - Can we still afford the connections?
- Need to watching what happens with taxing districts
- Sam Harris- Started a brainstorming doc with things we would like to see
- Need to figure out what our ask will be on the library improvement funds

- Quiet quarter
- ALA released a statement this morning on the results on the election: Vowing to continue defending IF from any threats
- ALA Exec. Board has an open self-nomination period for candidates
- ALA Exec. Director search? Still in process
- Alan Inouye- led the office of gov; retiring next year
- ALA Webinar on loan forgiveness- big success this year
 - Expect to see this pop up again
- United Against Book Bans
 - Book resumes on website is a great resource
- Sarah- Thank you to Steven for the past 6 years and all of your hard work!

- 2024 Presidential Summit
 - 10 days away, Saturday Nov. 16
 - 299 registrants! Free access to WA library employees
 - Added a further reduced rate for WLA student members- \$20 to \$10
 - Fewer states have offered the statewide access
 - Able to offer honoraria to speakers
- 2025 WLA Conference
 - Theme: Building Bridges & Connecting Communities
 - Program RFP is currently open! Please share this form and proposals are due Dec. 4
- Sarah- Thank you to the team for putting on these events!

PNLA Report-- Shawn Schollmeyer

- Conference season is starting for the PNLA- Second weekend in August, 7-9
 - 2025 conference will be virtual
 - Debbir Kramer- Exec. Director to handle conference coordination
 - Theme: Reach Farther, Connecting Libraries Beyond the Screen
 - Proposals will open in December
 - First planning committee meeting will be held this month
 - Lesley- 2026 conference? 2026 PNLA Conference will be in Oregon. Still planning to do a joint conference; waiting for MOU to come through
- New organizational President is Star White

Treasurer's Report-- Muriel Wheatley

- WLA 2025 budget
 - Board retreat was amazing and happy to meet everyone in person!
 - Initial review for the 2025 draft budget is done

New Business

- 2025 Budget
 - Fiscally conservative in our budget; often not as in the red as our budget suggests
 - 2024- budgeted a \$58,000 deficit; actual right now is a little over \$8,000
 - Moving toward reducing the deficit and moving us in a neutral direction
 - Pretty standard; a lot of the numbers have not changed
 - PS contract still the same
 - Changed:
 - Conference- Increased revenue based on location, etc.
 - Increased expenditures: rental is higher, F&B minimum, etc.
 - ScLD: budget request this year
 - Send people (Mahlon Landis- 2025 ScLD Chair and AASL Councilor) to two conferences, ALA and AASL
 - Hotel, registration, travel
 - Don't anticipate spending this whole number; working with estimates
 - 2 sections CATS and LIFE deactivated for the next couple of years, so they are not receiving their allotment at this time
 - Motion to approve the WLA 2025 budget: Elizabeth Brown
 - Second: Judy Pitchford
 - Aye: Judy Pitchford, Carol Ellison, Muriel Wheatley, Rickey Barnett, Steven Bailey, Elizabeth Brown, Sarah Logan, Elizabeth Roberts
 - Lobbying contract for Carolyn is coming up for renewal- just changing her rate
 - Increase for her contract, \$500 a month increase from \$2,500 to \$3,000; will increase from \$30,000 to \$36,000 annually
 - Since 2017, has kept a flat cost of \$2500; Prior to 2017, only got \$1,100
 - First increase in the past 7 years
 - Elizabeth R.- no problem with increase
 - Evaluation of our lobbyist? Have we ever done something like this?
 - Lesley- Does not recall ever doing this. We've been with Carolyn for quite a long time and has not seen a review like this
 - Sarah- Brianna has been reaching out to other ED's about this eval process. Can continue this conversation but after the legislative session
 - Lizzie: Good question to be asking, evaluate someone who is contracted; Are they doing the objectives outlined in the contract?
 - Task force? Think about it as a board? Conversation after leg session; could do the groundwork for this discussion during the leg session
 - Steven- [re: increase] Sounds like money well-spent!
 - Needs to go to a vote:
 - Motion to approve the contract: Elizabeth Brown
 - Second: Steven Bailey
 - Aye: Elizabeth Brown. Muriel Whealey, Judy Pitchford, Rickey Barnett. Carol Ellison, Sarah Logan, Steven Bailey, Elizabeth Roberts

Sarah and Elizabeth Roberts

PTA Assembly- Where the State PTA defines the legislative agenda for the year

- Wrote and submitted a resolution about a strong library program- passed!
- Should have their support now; trying to broaden the support for school libraries from other people who are not school librarians
- Three areas we are focusing on:
 - Big gap in education funding between actual cost to run the programs and the funding school districts get
 - MSOC funding- library books are part of this, but inflation has outpaced this number
 - Transportation- funding not adequate enough to cover
- Gavin took this resolution to WEA
- Media literacy and digital citizenship- good argument for the position at OSPI and doing something for school libraries
- OSPI- 800 people with a Teacher Librarian credential not working at a school library

Shawn- Now the Special Libraries Representative-Elect for the WLA board

- Can talk about what the WLA PNLA position would look like
 - Currently it is a non-voting advisory position to the board
 - Office can take the first pass at this description and bring this to the next board meeting; will appoint a new person for 2025
 - Any recs?
 - Time commitment: Worked with the PNLA conference planning committee
 - Report to the PNLA on what was going on with WLA; quarterly board meetings
 - Put in about 10 hours a month; though it's as much or as little as someone wants to put into this position
 - The PNLA is gathering more state reps, so reports are a bit more robust

- Interim Executive Director Report- Lesley Bourne
 - Dashboard report
 - Membership totals have gone down a bit, but we will see a jump when conference registration opens
 - Still waiting to see how the new membership rates have affected our membership totals
 - New 2025 Pawsident
 - Sara Jones' Mylo!
 - Raised about \$1500
 - IMLS Grant- Rickey and Lesley
 - Trauma-informed care in leadership in the library field (Presidential Summit)
 - 2-page proposal has been accepted
 - Keeping an eye on the current state of things
- Staffing Update- Kate Laughlin
 - WLA's new Executive Director
 - We did have 2 strong candidates, but we found our ED! Ainsley Nabaro
 - MOU agreement with Primary Source
 - PS put forward a proposition to finance half of the WLA position, with the added fundraiser responsibilities (position is also going from half time to full time)

- Goal by end of the year is that WLA will be able to afford the full time ED position in 2026 onwards
- If goal is not met, we will have to start looking at a reduction in services
- State Library Report- Sara Jones
 - \circ Problems with funding
 - Recording fees, refinancing of homes has gone down
 - 3.4 million hole, asking for this to be plugged
 - WA state experiencing difficulties with budget
 - Billions in shortfall
 - SoS is not funded as well as it could be
 - Proposal is 6%, wanting to propose less, around 3%
 - Worried about federal funding sources
 - We need to make sure people understand the values of libraries
 - Encourage everyone to contact local legislator and let them know you are a constituent and libraries are important to you
 - Grassroots efforts
 - Still waiting for a Director to be named
 - We're doing great work and will continue to serve our communities to the best of our abilities
- Legislative Report- Kiersten Nelson
 - Legislative Day tomorrow- nice to have this earlier date
 - Long session year (runs until April) with a full budget
 - Feb. 21- cut off for when we see what bills stay alive and which will fade away
 - Lots of bills will go into hearings, having conversations for which bills will be pushed forward
 - Number of public and school library bills we are looking at nice to see this variation
 - HB1503- Digital Equity Bill
 - HB1517- wireless device tax
 - Funds will go to enhancing digital equity grants
 - Less than ideal for libraries, who will have to pay this \$2 tax
 - Public Library Bills
 - 1% live lift levy to 3%- huge bill for funding libraries around the state
 - WLA and PL Directors championing
 - Budget proviso
 - Asking for a set amount of money (\$500k) to conduct a study of digital content and pricing models in public libraries that have to pay for this without ability to own the copy
 - Public worker protections
 - School Library
 - Information technology programs
 - School levies no longer have to rely on the super majority in order to pass, 50+1

- Has WLA support
- State employees' access to peer-reviewed journals
- Treasurer's Report- Rob Mead
 - Large drop in dues
 - Hoping that the new rates will encourage people to join
 - Annual conference will hopefully bring in a good amount of revenue
 - West side conference will likely make more money than the east side conferences
 - Incentive to join to attend the conference as well
 - Reminds people to renew their memberships
 - Investment accounts have been doing well- money is now in a Fidelity account
 - Still taking money out of these accounts- goal is to break even and stop taking from these accounts
- ALA Report- Gavin Downing
 - LibLearnX- small conference, last of the midwinter LibLearnX events (not making money), 1,600 people total
 - Highlight was MLK Sunrise Celebration
 - Sundance Film Festival was happening at the same time- "<u>The Librarians</u>"
 - Passed a new interpretation of prisoner's right to read
 - Resolution about the executive board composition; Elected new officials
- Events- Rhea Allen
 - 2025 WA Library Legislative Day
 - We have 68 advanced registrants- form now closed but able to show up in person
 - Schedule is online
 - 2025 WLA Conference
 - Registration is opening today at noon! Opening a day early because of Legislative day tomorrow
 - Can see the program conference schedule online
 - Keynotes:
 - CAYAS/ScLD Breakfast: Peggy Janicki, nominated for the 2025 Towner award
 - Closing session: Shamichael Hallman, part of the urban library council and author
 - Third keynote invite for welcome breakfast has been sent to Sasha LaPointe
- 2025 Presidential Initiatives- Rickey
 - Advocacy- continuing educating everyone we know about supporting libraries
 - Supporting library workers- workers in all settings and types
 - Intellectual freedom- connecting with other state orgs to learn from each other
- Share Outs/Comments

 - Shawn- Would like to see more support for the WLFFTA section; how do we

recruit more folks?



One activity/goal in the last quarter in your area to share:

I have been working with Lesley, Shamim, and the Events Committee to prepare our final IMLS grant submission for the 2025 Presidential Summit. It's exciting to see how things are coalescing around the theme of supporting library workers through a trauma-informed framework.

Work/activities/goals coming up in your area in the next quarter that you are excited about / What you hope to accomplish by next board meeting:

Alongside the 2025 Summit, I am excited about progress on hiring WLA's new Executive Director.
