

### Loleta D. Fyan Grant for Public Libraries

The American Library Association's Library & Research Center is now accepting applications for the Loleta D. Fyan Grant, a grant for up to \$5,000 for the improvement of public libraries and the services they provide. Loleta D. Fyan, ALA President 1951-1952, believed that every individual, regardless of residence, is equally entitled to high quality library service and that librarians must be adept in using the political process to acquire this "right of citizenship."

The grant, up to \$5,000, is to be used for the development and improvement of public libraries and the services they provide. The project should:

- result in the development and improvement of public libraries and the services they provide;
- have the potential for broader impact and application beyond meeting a specific local need;
- be designed to effect changes in public library services that are innovative and responsive to the future; and
- be capable of completion within one year.

Applicants can include but are not limited to: local, regional or state libraries, associations or organizations, including units of the ALA; library schools; or individuals. The ALA Office for Intellectual Freedom (OIF) is seeking information on challenges and censorship incidents that occurred in 2018 in

libraries, schools and universities. Library workers, educators and community members are encouraged to **submit reports** to OIF by December 31.

OIF tracks challenges throughout the year and provides confidential support to educators facing censorship attempts. Reporting challenges that occurred from January 1 - December 31, 2018 will help OIF identify censorship trends, craft resources, and provide updated information for the annually published **Top 10 Most Challenged Books** data.

Anyone can report challenges. Those who do can indicate on the **reporting form** whether the incident is public (additional information can be shared in public reports) or confidential. Challenges and bans can range from books, artwork and databases, to speaker disinvitations, book displays and programs.
