2023 Bylaws Changes Vote by Aug 4

WLA Member? Please Vote on Bylaws Revision!

If you're a WLA member, don't forget to vote on the bylaws revision by **Aug. 4!**

WLA is now a 501(c)(3) organization. This organizational change will allow for WLA to apply for grants as well as allow donations to be tax deductible. Since these changes require updating the WLA Bylaws, the WLA Board took the opportunity to remove or replace outdated language, make consistency edits, and take out specific content that is subject to more frequent change. That specific content has been moved into WLA's updated policies and procedures (living documents) instead of being housed in our organization's Bylaws (a general operations document).

The WLA Board recently held a unanimous vote to approve all edits to the WLA Bylaws. It is now **required that our members vote on these same changes.**

Secretary of State Honors Walla Walla High Students for Efforts to Stop Book Bans

Secretary of State Steve Hobbs was in Kennewick on July 25 to meet with election officials and recognize local high school students for their efforts against recent book bans.

Walla Walla High students Ava Kirtley and Arin Iverson are the founding members of the Banned Book Club, which works to keep banned books in schools and protects access to them for students interested in reading the controversial titles. Secretary Hobbs honored them, along with Walla Walla High School library media specialist Kim Casetto, for their efforts. Kirtley, Iverson, and Casetto were interviewed about their experiences as part of a panel on censorship at the 2023 WLA Conference.

"We have to respect the first amendment," Secretary Hobbs said. "It's a freedom and books are part of that." To read the full article and watch the news clip from the event, [visit here](#).

Survey on Abortion Information in Pubic Libraries

On June 24, 2022, the U.S. Supreme Court ruled in *Dobbs v. Jackson Women's Health Organization* that abortion is no longer protected by federal law. This

repealed Roe v. Wade. The questions in this survey are about the aftermath of that decision and its impact on public libraries in the United States.

To be eligible, participants must be at least 18 years old, work in a public library in a state or territory in the United States, specifically in reference or collection development. All study materials have been approved by the University of Wisconsin Madison's Institutional Review Board (IRB).

Participation is confidential. No identifying information is collected. The survey will take approximately 10-15 minutes to complete. [Access the consent form and survey.](#)

SHLB Thrilled with FCC E-rate Reforms, Simplifying Application Process for Schools and Libraries

Washington, D.C. (July 20, 2023) - The Federal Communications Commission (FCC) approved a series of significant reforms to the E-rate program, with the aim of simplifying the application process for Tribal libraries and small and rural schools and libraries nationwide. These changes will mark the most substantial updates to the \$2.8 billion E-rate program since 2014 and are expected to increase funding and enhance broadband connectivity for rural America.

In addition to clarifying the E-rate rules for Tribal applicants, the forthcoming Order provides an exemption from the competitive bidding process for libraries seeking less than \$3,600 in Category Two support and waives the cost allocation rule for all schools and libraries if at least 90% of an applicant's cost is for eligible E-rate uses. The cost allocation waiver could be particularly important, as SHLB and others [requested](#) a waiver of the cost allocation rule over two years ago. The Commission also adopted a Further Notice of Proposed Rulemaking, which proposes even further improvements.
